# Whittier Chocolate Company

## Rental Contract

1. CHOCOLATE PURCHASE AGREEMENT: The Customer agrees to purchase and use only chocolate sold by Whittier Chocolate Company. The Customer shall be liable in full for any damage to the Chocolate Fountain.

2. PAYMENT TERMS: Whittier Chocolate Company requires a \$150.00 nonrefundable deposit in order to reserve a Chocolate Fountain. To confirm this agreement, return one signed and completed copy of this contract along with the deposit of \$150.00 within 3 days. All credit card orders must be processed through PayPal via [cprendiz@whittierchocolatecompany.com](mailto:cprendiz@whittierchocolatecompany.com) under contact us page by clicking on the PayPal logo box. Payments can be paid in cash, check or credit card. EXCEPTION: No checks accepted for final payments. The final balance is due no later than 14 days prior to the date of the event. If check is used as payment, it should be made out to Whittier Chocolate Company. There will be a \$35 fee charged for all returned checks.

3. CANCELLATION: This agreement cannot be cancelled, except in writing, by either the Client or Whittier Chocolate Company. If the Client initiates the cancellation, Whittier Chocolate Company will keep the \$150.00 deposit. Written notification to Whittier Chocolate Company is required 21 days prior to the event date to receive a partial refund of other monies paid. After 21 days, your deposit can be used toward another date within 120 days. The client may request to change the date. However if the requested date is not available the Whittier Chocolate Company cannot be held liable. The Client will hold harmless, Whittier Chocolate Company in the event of illness, injury, act of God, or any other situation beyond control of Whittier Chocolate Company that prevents Whittier Chocolate Company from performing.

4. PROVISIONS: Whittier Chocolate Company requires access to the desired set-up area at least 60 minutes prior to the scheduled start time. In addition, 60 minutes are required after the conclusion of the service period for take down and removal. The Client is responsible for providing a sturdy, level table capable of supporting at least 150 lbs. Client is also responsible for providing two table linens that coordinate with their color scheme. Chocolate Fountains requires at least one - 120 volt circuit within 8 feet of the desired set-up area that adheres to contemporary safety standards and supplies at least 15 amps. Once the Chocolate Fountain has been set up in the desired location, it cannot be moved during the event. Client accepts full responsibility and is liable for any damages, injuries or delays that occur as a result of failure to comply with these provisions. Whittier Chocolate Company reserves the right to use any picture(s) from the event in advertising. Chocolate Fountains are for INDOOR use only.

5. LIABILITY: This Agreement and the contents hereof represent the only warranties, express or implied, between the parties, including any implied warranty of merchantability or fitness for the particular purpose and for any other obligation or liability on the part of the Whittier Chocolate Company. Whittier Chocolate Company shall not be liable for any injury, loss or damage directly or consequently arising out of the use or inability to use the Chocolate Fountain, whether used singularly or in conjunction with any other equipment. In the event of litigation all parties agree to mediation and/or small claims court. Any litigation will be restricted to the county of Los Angeles, in the state of California. Client will indemnify Whittier Chocolate Company against, and hold Whittier Chocolate Company harmless from all claims, actions, proceedings, costs, damages and liabilities, including attorney fees, arising out of, connected with, or resulting from the use of the Chocolate Fountain.

6. AUTHORITY: Only the person signing this contract can alter the Date and/or Times for the Chocolate Fountain Rental and Usage. The Whittier Chocolate Company will attempt to fulfill a request on the rental date; however there is no guarantee that extra usage time will be available. There is a fee for extra hours of Rental that are due and payable at the time of the request
